List of bills subject to change and be updated regularly

1. Christian Social Justice:

- a. **Oppose the New Racism (CRT) and support Marriage & Family, Faith/Virtue:** Oppose the New Racism (Critical Race Theory) and support a Christian approach to addressing Racism and disparate impact by promoting marriages, the family unit, and virtue, not CRT, 1619 Project, and BLM movement, racial/diversity/gender/LGBTQ quotas, reparations, segregation, and intersectionality.
 - i. Oppose [SB 5044](#) - Concerning Professional learning, equity, cultural competency and dismantling institutional racism in the public schools
- b. **Support School Choice Vouchers/Homeschooling:** Public Schools are indoctrination centers designed to corrupt and abuse children sexually and racially and turn them away from parents and faith. We must encourage parents to vacate public schools for homeschooling or private schools.
- c. **Support Drug Reform, Oppose Legalization:** Oppose promotion or decriminalization of Hard Drugs, Marijuana expansion, and using Heroin Injection Sites, and support Drug abstinence, Diversion Programs, and treatment per AA model.
 - i. Oppose [HB 1019](#) – Allowing residential marijuana growing
- d. **Support Overturning Conversion Therapy Ban (talk therapy):** Per recent 11th Circuit Court decision. Reinforce laws that address therapeutic child abuses under any circumstances.
- e. **Oppose Transgender Mandates** (Mandatory pronouns, Mixed sex bathrooms, quotas, Child indoctrination programs (Drag Queens), Ban Men playing Woman sports etc)
- f. **Oppose anti-Christian Indoctrination and censorship Programs:** (CRT, Intersectionality, Diversity, BLM, Abortion, LGBT, Marxism) in schools, colleges, businesses, professional organizations, and promote family, marriage, virtue/faith
- g. **Support Homeless and Drug Reform Programs (Union Gospel Mission model):**

2. Life:

- a. Support [HB 1008](#) – Preventing abortion on the basis of Down’s Syndrome
- b. **Oppose PP Student Health Clinics and expansion of abortion telemedicine**
- c. **Oppose Abortion expansion:**
 - i. Oppose [HB 1009](#) – Concerning Student health plans
- d. **Oppose all budget abortion spending increases:**

3. Marriage and Family:

- a. **Support Marriage:** Support Marriage Commission
- b. **Oppose Paid Surrogacy:**

- c. **Oppose Child Gender Transition efforts:** Identify and ban Child Hormone blockers/surgery as child abuse and genital mutilation
- d. **Oppose Gender as category:** replace with biological male/female sex
- e. **Oppose Prostitution Legalization.**

- g. **Oppose Human Trafficking and Pornography:**

4. **Parental Rights:**

- a. **Support Parental Rights:** Support Parental Rights Commission to overturn any statute that diminishes parental rights in any way.
 - i. Oppose [SB 5030](#) – Creating a comprehensive School Counseling program
 - ii. Support [HB 1048](#) – Removing religious references regarding criminal mistreatment of children and vulnerable adults; allowing for the use of “religious healing”
- b. **Oppose Child Emancipation:** Oppose eliminating parents’ rights to raise or be informed about their child’s activities.
 - i. Oppose [SB 5030](#) – Creating a comprehensive School Counseling program

5. **Religious Freedom:**

- a. **Oppose Vaccine religious exemption elimination:** add parental/personal exemptions.
 - i. Support [HB 1006](#) – Preventing mandatory vaccinations
- b. **Support Free Exercise of religious worship or religion during emergencies:** Designated essential service and not under Gov emergency orders and mandatory leg approval.
 - i. Support [HB 1004](#) – Restricts emergency mandates
